Me: Because they say I can take a shower by myself and can put on a pair of pullover shorts and shirt.

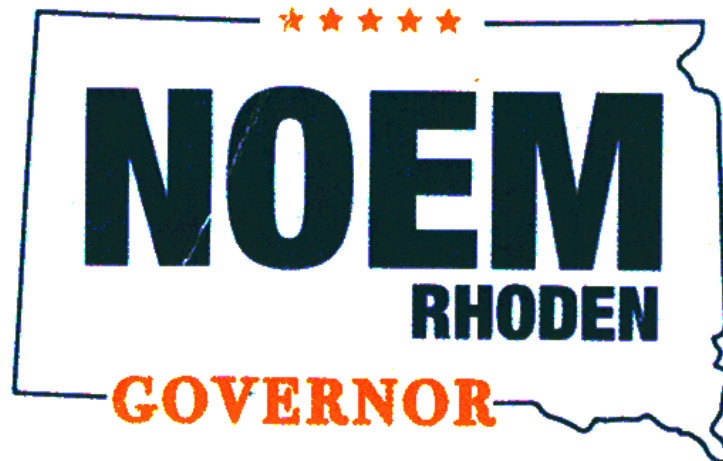
Gov Noem: Something's wrong....

# Brunner Steps Down as Commissioner of School & Public Lands



PIERRE, S.D. – Today, Governor Kristi Noem appointed Jarrod Johnson as Interim Commissioner of School and Public Lands, effective February 1, 2022.

The current commissioner, Ryan Brunner, will step down from his position and join Governor Noem's office as a senior policy advisor. Ryan's last day in elected office was January 31, 2022.

"Ryan has been a tireless

Office," said Governor Kristi Noem. "Jarrod will be a capable and qualified steward of the office until the next commissioner is elected by the people."

"This is a great opportunity to serve the state of South Dakota," said Brunner. "As I term limit this year and transition out of office, it is an honor to be asked by Governor Noem to join her administration."

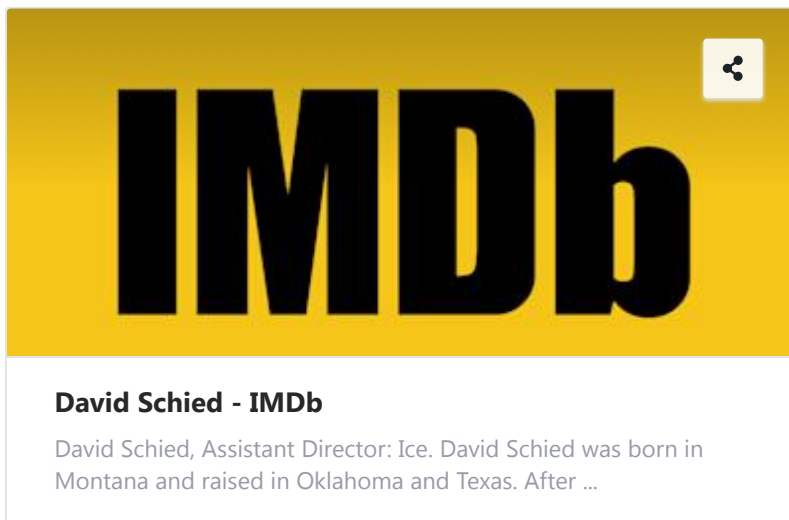

"MEDICAL ASSISTANCE") support.**

My SECOND attachment is a recent (12/1/21) document referenced by the first (39-page attachment), being a letter written immediately after my meeting with DSS agents (Angie Reichert in LTSS) and principal (Tom Eads as REGIONAL DIRECTOR) who are committing gross levels of FRAUD in the processing of my well-RECORDED (i.e., in both audio and video) claims in protest of the previous mishandling(s) of my (persistingly, wrongly processed) initial MEDICAID "application," and SOUTH DAKOTA's refusal to provide constitutional "Full Faith and Credit" to the FACT that I arrived here from MICHIGAN in February 2021 with MEDICAID intact ... since losing my two legs and seven fingers.
