We are writing to you about your Social Security benefits.

**What You Should Know**

The State of Michigan will pay your Medicare medical insurance premium beginning February 2021.

**What We Will Pay And When**

We pay Social Security benefits for a given month in the next month. For example, Social Security benefits for March are paid in April.

- You will receive \$297.00 around March 19, 2021.

## Obama veteran, CFO of College Board picked to head state health department

Robert Gordon, senior vice president of finance and global strategy at The College Board, is joining Gov. Gretchen Whitmer's administration as director of the Michigan Department of Health and Human Services.

Gov. Gretchen Whitmer is turning to a veteran of the Obama administration who helped guide federal budget planning to run the Michigan Department of Health and Human Services, a massive government agency that has been operating in a state of turmoil for the past three years.

Robert Gordon, senior vice president of finance and global strategy at The College Board, is joining the Whitmer administration on Monday as the new director of DHHS. He was previously a high-level official in two federal agencies in President Barack Obama's administration.

Whitmer is tasking Gordon with running a 14,000-employee state department with a \$25 billion budget that she has described as "enormous" and had mulled splitting up.

"He brings a unique set of skills and experiences that will lead the Department of Health and Human Services to drive real results that help hardworking families," Whitmer said in a statement.

DHHS oversees social welfare programs that directly touch one-quarter of the state's 10 million residents, works closely with managed care companies that administer Medicaid health insurance programs and has broad responsibilities over protecting public health.

It's the area of public health where DHHS has been under intense scrutiny for the past three years, for the state agency's role in the Flint water crisis.

The department's former director, Nick Lyon, and former chief medical executive, Eden Wells, are fighting involuntary manslaughter charges in Genesee County Circuit Court that stem from a deadly outbreak of Legionnaires' disease tied to Flint's disastrous

## Michigan GOP to probe Whitmer \$155K 'hush money' deal as new severances emerge

LANSING — Michigan Gov. Gretchen Whitmer is under fire for an expensive separation and confidentiality deal with her former health department director that experts are calling a rare arrangement that may fuel distrust.

It's "hush money," according to legislative Republicans, who plan to investigate the \$155,506 payout they contend was designed to ensure Robert Gordon will not discuss controversial COVID-19 orders that were developed behind closed doors.

Gordon announced his abrupt and unexplained resignation on Jan. 22, exactly one month before he signed an agreement with the Democratic administration that paid him the equivalent of nine months salary and extended health benefits.

The deal prohibits him from discussing the circumstances of his departure "in the interest of protecting deliberations among government officials," according to the document signed by Gordon and Mark Totten, Whitmer's chief legal counsel.

**What did that cost me and save the STATE OF MICHIGAN in monthly premiums for PART B by depriving me of that application and refusing to assist me in completing one over the phone? In premiums along, it saved the STATE \$145 PER MONTH, costing me the same by deductions from my monthly SOCIAL SECURITY payments. Moreover, because they also deprived me of the "EXTRA HELP" program at the same time, I was forced instead to having another \$14 or more deducted for several months to cover the costs of PART D too.**

**Yet the costs in premiums levied against me was not all. Because throughout the latter half of 2020 when MEDICARE "kicked in" and I was being wrongly charged with having to also pay for co-pays and deductibles based upon wrongful calculations of the FEDERAL USDHHS operating the MEDICARE program through the "doofuses" running the CENTERS FOR MEDICARE AND MEDICAID who repeatedly disregarded my letters of complaints beginning last August 2020 through early 2021, I am now saddled with debts totaling \$781.50 as shown in the MEDICARE SUMMARY NOTICE FOR PART B (Medical Insurance) seen in the attachment to this email as p.15.
