Dear Clerk of the Court.

Please process and file the enclosed sets of documents as itemized below and as appearing in my accompanying "Proof of Service" to this U.S. District Court.

Again, I wish to remind you that I am a bona fide totally and permanently disabled quad-amputee with difficulty handling small objects; and that I have a "Motion" and "Application" paperwork already in the COURT for "E-FILING" with electronic signature still awaiting processing on a completely different and earlier case ("David Schied v USA, et al") that I filed nearly two months ago on 4/22/21. In accordance with the good faith assurances that I received back from you in the aftermath of the last DENIAL of any "reasonable accommodation" leading to my having to send back my documents at the Court's cost, I have electronically "signed" these latest filings "as if" they are to be electronically filed by you as you had previously stated into the RECORD for that other case, at least until my E-FILING status is recognized and the proper training finally ensues.

Please also be reminded that, as the enclosed documents show, my latest "FORMA PAUPERIS" application for "Waiver of Fees and Costs" is slightly changed from the previous one submitted two months ago relative to it being applied to an altogether different case. Moreover, despite that I am herein also filing a completely different case from the previous "David Schied v USA, et a?" there is the need for only one single need to be approved for and trained for "CM/ECF" filing status. Therefore, the one enclosed - which clarifies my "litigant" status as "sui juris" rather than "pro se" - supersedes and replaces the preceding filing for purposes of being "once and for all" approved and trained for CM/ECF" filing status.

Finally, in reminding you of the problems that played out in the previous case filings - in which the OFFICE OF THE CLERK had initially denied me "access" to the Court under the FALSE CLAIM that I had not complied with Rule 11(a) and without providing me with the "spirit" of the ADA by way of "reasonable accommodations" (by claim that I should otherwise provided "hard" signatures on "original" documents "signed" legally as would be reasonably executed by a "quadamputee") - you should be reminded that if you once again deny me access again in the same way as before, after I have gone out of my way to get third party transportation to the post office and after paying the full costs for postage to deliver documents by "snail mail" because your office refuses to deal with me at the counter face-to-face (claiming COVID as the reason), then I will once again refer to our earlier RECORDED phone discussion which resulted in your office sending me "prepaid postage" for the return of my filings back to you, with the same expectation that you will need to follow-up again in the same way.

Further, and lastly, I wish to remind you that while I know that constitutional <u>SEPARATION OF</u> <u>POWERS</u> precludes the "judiciary" from being "subject to" the <u>AMERICANS_WITH</u> <u>DISABILITIES ACT</u> legislation, the Judiciary is nonetheless still subject to We, The People; and like before, as I have long been applying the COMMON LAW in that other case of "David Schied v USA, et al" in an ARTICLE III COURT OF RECORD, when the "Court" seeks to undermine the sovereign Rights – including the spirit if not the letter of CIVIL RIGHTS legislation – then it is up to me, as One of the Sovereign People and as a "<u>Private, Public Proxy</u>", to hold the "judiciary" accountable by COMMON LAW terms, even as I am still doing relative to that previous circumstance.
