Dear Andrea,

I am writing to once again spending your time to consult with me over the phone this past week; and for following up by mail with the new RX program change with which you assisted me.

I left you a voice message near the end of the day yesterday in reminder of your also stating that you would assist me further by reporting to "DAKOTA AT HOME" as an agency of the SOUTH DAKOTA DEPARTMENT OF HUMAN SERVICES, that I am being treated as a *"neglected and abused disabled adult"* by STATE agents who have retaliated against me by taking away needed *"chore services"* to assist me weekly with *"independent living"* food preparation and cooking, shopping, cleaning, sanitation of bathroom and kitchen, etc. since I have mobility and handling problems being a recent (2018) *"totally and permanently disabled quad-amputee"* without legs and fingers due to amputations caused by the deadly *"sepsis"* disease.

As a reminder, this retaliation has resulted as a response by the *"ADMINISTRATIVE 'DEEP' STATE"* to my executing my own *"self-advocacy"* this past eighteen (18) months of being denied *"MEDICAL ASSISTANCE"* (a.k.a. *"MEDICAID"*) that would entitle me to the many more government benefits that should otherwise be available to me under the money the STATE already receives from the legislation of the U.S. CONGRESS for people like me; and by my *"exhausting [my/their] administrative remedies"* and now holding the *"Deep State actors"* accountable by taking the evidence of their corruption to the STATE courts (as well as to the ultimate "court of public opinion if I continue to be denied access to a *"jury of my peers"*) for settling these matters.

Please notify me when you have made this “*report of neglect and abuse*” and include the name and contact of the STATE agent in receipt of this report, so that I may do the proper follow-up for accountability in the event that your report is not acted upon immediately to provide me with the help that I need in accordance with the provisions of both STATE and UNITED STATES laws.

Please also note that, per my call yesterday to you, I left a message stating that CIGNA RX has indeed honored (at least so far) my assertion of being a reported CRIME VICTIM resulting from my being illegally evicted from my home in the STATE OF MICHIGAN about 19 months ago; with my exercise of rights to keep my home location out of any records that may be shared by governments or their CORPORATE licensees like CIGNA as I now establish firm CLAIMS against the STATE OF SOUTH DAKOTA and its DSS and DHS “*agents*” for these “*discriminatory*” abuses of process and tortuous acts of retaliation against me for simply making my stand (even without legs) on the laws and facts as these facts are all supported by evidence.
