**As provided by law, please send to me in the next 10 days:**

**All RECORDS from within this past EIGHT (8) MONTHS – whether they be in the form of emails, memorandums, handwritten documents, telephone calls, or any other form of communications – associated with notifications for, about or on my (David Schied) behalf pertaining to my disability and the possible need for intervention services by the STATE.**

This will include, but not be limited to, any and all communications – internal or external to the STATE departments, bureaus, divisions, sections, agencies, units, and offices, etc. – regarding reporting of “neglect and/or abuse” and/or any associated “referral” for services such as may be submitted to the DSS and/or DHS “*SECRETARIES*” and/or their AGENTS.

This will also include, but not be limited to any and all communications submitted by medical professionals, social service professionals and/or volunteers, private and/or nonprofit CORPORATIONS, advocacy groups, and/or medical service contractors and/or licensees.

For all records located, provide the names and titles of all persons associated with the records – whether natural persons or corporate, government, or quasi-government “*persons*”; and provide all documents related to what action took place in the aftermath of receiving such records.

**As a “reasonable accommodation” under the ADA, I request that these records be provided directly to me in copies since I am a “totally and permanently disabled quad-amputee” and reported CRIME VICTIM being DENIED ACCESS to transportation and thus, to my community, by DENIAL OF MEDICAID. You may use the mailing address at the top of this letter.**

**Note also that I request the waiving of costs and fees since this request is being made not only in my own interest as “BENEFICIARY” of the Welfare System, but also as a “Private, Public Proxy” acting in the capacity of a PRIVATE ATTORNEY GENERAL looking out for the “important public interest” of both State and United States “TAXPAYERS” looking into STATE government operations and the report of “RICO” CRIMES committed by STATE government agents and STATE BAR members.**
