Instead, just send notice of anything else required while still sending me either proof of filing or case number related to the docketing of each of these two cases.

Please also note that since I was DENIED “*access*” to the court to such extent that NONE of the named CO-TRUSTEES (except the “*representative counsel*” for the UNITED STATES as “*TRUSTEE*” for EACH case) were allowed to be served in these cases – and only Matthew Thelen is marked by the COURT OF APPEALS as the “*receiver / agent / principal*” for each action on behalf of ALL LITIGANTS in both cases – only he is being served (via email) by the pre-established standard established between he and I as a matter of this ARTICLE III COURT OF RECORD.
