The documented acts of GROSS NEGLIGENCE and MALFEASANCE of the EXECUTIVE BRANCH throughout 2021 now justify taking these matters to the COURT'S for civil litigation, to the LEGISLATURE for criminal IMPEACHMENT proceedings, and to the PRESS for common law remedies.

I am writing for the twofold reasons referenced above as highlighted on the previous page – <u>FIRST</u> to recap the events having taken place over the course of this past year of YOUR collective deprivation of my rights to STATE "*Medical Assistance*" ("<u>MEDICAID</u>"), and <u>SECOND</u> to respond to YOUR untimely and deceptive letters of 1/11/22 and 1/18/22 sent to me by <u>Angie</u> <u>Reichert</u>, as well as the "(SNAP) <u>RENEWAL NOTICE</u>" sent to me by <u>Sharon Maher</u>. I will address the matters separately below on the following pages.

<u>First, to be noted</u>: I am a 64 year old Anglo-American male who has been "totally and permanently disabled" and rendered "Medically Fragile" and at an "Nursing Home or Institutional '<u>Level of</u> <u>Care</u>" since I entered the hospital as "incapacitated" in March 2018, with my legs and fingers having been amputated in May 2018.

David is a patient of mine. He has had <u>amputations of 7 of his fingers and bilateral below the knee</u> <u>amputations</u>. He is permanently and totally disabled. From his amputations he is essentially a quad amputee. Because of these amputations he has difficulty completing ADLs and is frequently home bound due to complications of his amputations. David is dependent on equipment for his daily life and is essentially considered nursing home or institution level of care.

With regard to the "DECEPTIVE PATTERNS AND PRACTICES of persistent DENIALS":

A. **<u>STATE MEDICAID</u>** – As you are all already well-aware:

I have attempted to resolve the matters of YOU acting on behalf of the Sovereign People of this STATE OF SOUTH DAKOTA refusing to act on my behalf to remedy my declaring myself to being a bona fide "CRIME VICTIM" and "REFUGEE" from the STATE OF MICHIGAN from where I fled under "Threat of Life and Death" when CRIMINALLY EVICTED last winter during a NATIONAL "COVID" PANDEMIC and accompanying EVICTION MORATORIUM. As you know, YOUR "Attorney General" Jason Revnsborg and his so-called "investigator" Richard Bauman – being preoccupied by Revnsborg pleading "no contest" to criminal prosecution for "involuntary manslaughter" – were derelict in refusing to properly respond to my reports of needing crime victim and other services upon my arrival to South Dakota in homelessness as shown by the RECORD of correspondence in late Winter 2021.

As you also are already well aware, I spend the entirety of last year engaging (minimally) in the following written and oral dialogues with your FUNCTIONARIES to no avail when requesting that your STATE agents and principals provide constitutional "*Full Faith and Credit*" to the FACT that I had arrived here with MEDICAID COVERAGE issued in the STATE OF MICHIGAN from March 2018 when I was rendered incapacitated by SEPSIS DISEASE, which nearly cost me my life, and did cost me my two legs and seven fingers due to surgical amputations on May 5th and May 7th (2018) respectively, rendering me forever after a "totally and permanently disabled quad-amputee" and a WELFARE BENEFICIARY for the rest of my natural life.

What is starkly obvious from the above RECORDS is the fact that nobody missing two legs and all but one pinky finger should need to go through all of the above in fighting STATE functionaries – to anywhere fractional to this extent – in order to receive MEDICAID "*Medical Assistance*", especially being that this all began as I was just three (3) years post-amputations and <u>still in many forms of recovery</u> with "*special needs*" ... AND reporting myself to be a bona fide CRIME VICTIM of recent <u>forced homelessness</u> by the agents of another STATE.

Secondly, the details contained in the above-referenced RECORDS reflects that not only has the functionary agents and principals of the STATE committed numerous acts of "*deprivation of rights under color of law*" (civil: <u>42 U.S.C. § 1983</u>; criminal: <u>18 U.S.C. § 242</u>) but executed in such fashion with deceptive qualities characteristic of a criminal conspiracy by a RICO organization (<u>18 U.S.C. § 242</u>; <u>18 U.S.C. § 1961 *et seq.*</u>) These claims are particularly underscored by the combination of EVIDENCE surrounding the following:

- a) The FRAUDULENT paper trail being generated by Angie Reichert and the DSS pertaining to the existence of a "second application" is superseded by both the previous long history of formalized COMPLAINTS about the improper handling of the STATE functionaries of my "first application" for MEDICAID (a.k.a. "Medical Assistance") and the EVIDENCE I located in public records that not only are these STATE agents disregarding the letter and the spirit of both STATE and UNITED STATES laws when denying me MEDICAID; but so too, all of these "discriminating women" as "gatekeepers" employing Critical Race Theory and Gender Bias have documented questionable backgrounds liken to malebashing, racial discrimination, and Marxist-Socialist programs sponsored by the NIH and their Chinese Communist Party (CCP) finance partners.
- b) That to cover up my LEGAL inquiries and demands under the STATE and UNITED STATES "Open Records" laws and FREEDOM OF INFORMATION ACT for

government transparency about the "*qualifications*" of the DSS/DHS "*Team*" of women who are DENYING me MEDICAID based upon their own biased and unwritten criteria for <u>qualifying and disqualifying</u> my eligibility based upon "*level of need*" – **cited only as such in writing but revealing on RECORDED phone conversations that is it** "*because* **[I]** can 'shower'" myself (without legs and crawling onto a bench in the shower) and "dress" myself (albeit with <u>only</u> pullover shorts and T-shirts) – the BAR attorneys of the EXECUTIVE BRANCH, being <u>Jenna Howell</u> and <u>Jeremy Lippert</u>, are first delaying "open records" responses for well over three (3) months beyond what is allowed by law, but also then DENYING every single one of the document inquiries/demands on the qualifications of the functionaries themselves, as well as the written criteria for establishing the "policies and procedures" being used by these DSS/DHS agents and principals for disqualifying me from receiving MEDICAID. (See the lame and late "answers" below as written out by Howell and Lippert in persistent DELAY and DENIAL responses to my reasonable OPENS RECORDS requests issued both on 6/2/21 and again on 8/7/21, as sent on the following documented dates (as shown in the subsequent pages).

By this letter, I am hereby OBJECTING to and DENYING your assertion that you need six (6) more weeks — beyond the previous three (3) weeks you stated you needed, which is beyond the previous six weeks that you forcefully TOOK prior to that (by failure altogether to even acknowledge my SECOND "Open Records" reminder that my FIRST "Open Records Request for Documents" had remained totally ignored by your collective STATE "Departments" of the DOH, the DHS, and the DSS - to "answer" my SECOND "Open Records Request for Documents".

Let's review the past RECORD of dereliction for possible consideration that it may so GROSSLY NEGLIGENT and with demonstrated MALFEASANCE as to warrant CRIMINAL allegations:

1) As a "totally and permanently disabled quad-amputee" and reported "crime victim", on 6/2/21, I "filed" my FIRST COMPLAINT and OPEN RECORDS (a.k.a. "FOIA") "REQUEST FOR DOCUMENTS" with your "wheel" and "chain" collective of "agents and principals" as shown by the relevant graphics below as my UNREBUTTED PROOF.

I say "unrebutted" because - when NONE OF YOU provided any reply or "ANSWER" to either the COMPLAINT or to the OPEN RECORDS REQUEST - I wrote a SECOND COMPLAINT, more detailed than the first and jam packed with furthering EVIDENCE against ALL OF YOU, in addition to the SOUTH DAKOTA ATTORNEY GENERAL, spotlighting your high levels of dereliction, gross negligence, and malfeasance of duties to both ANSWER THE COMPLAINT and ANSWER THE "REQUEST FOR DOCUMENTS". Please provide the legislative grounds for having me complete a W-9 "Verification of Employment Authorization" or other "taxidentification" document, assuming this document is exactly the one that you appear to be coercing me to "sign under [criminal] penalty of perjury". This request is herein sent to you - as the agent for the principal of "SD DEPARTMENT OF HUMAN SERVICES / LONG TERM SERVICES AND SUPPORTS" - under the STATE Laws of Transparency, being South Dakota's FREEDOM OF INFORMATION ACT. Please also note that this request is being made with the purpose of showing "how government operates", and as such, I am requesting a WAIVER OF FEES AND COSTS to fulfill this request. Note that I believe myself also qualified for waiver because I have recently reported myself to be a CRIME VICTIM, a recent REFUGEE, a destitute, and a pauper living entirely on the welfare of others as those "taxpayers" for whom you may wish to have identified.

As long as you are at it, please also provide all documents that justify your reasons for denying my transportation costs in delivering the electric wheelchair to the doorstep of the business so that they could change out the batteries on the electric wheelchair at literally no added cost (beyond MY cost for delivery of the chair to THEIR doorstep).

What I am trying to determine - with the intent of sharing with others exactly how government works - is whether government is actually promoting a more expensive SOCIALIST system in which I - as on of the sovereign People and as a totally and permanently disabled quad-amputee - would have been deemed "better off" for following a complicated (and possibly prohibitive to disabled persons) path to having an entirely new electric chair ordered for thousands of dollars in cost from a "medically approved" DEALER (in what appears to be a growing FASCIST society) or whether my taking a private (and clearly much cheaper) path to a simpler and quicker resolve (in practical, private, and COMMON LAW terms) makes me "better off". As things look so far, my good faith efforts to keep things simple are resulting in CRIMINAL THREATS that I cannot appreciate in the least, particularly as a disabled person.



Section 1-27-37 - Written request for disclosure of records

If an informal request is denied in whole or in part by the custodian of a document or record, a written request may be made by the requestor pursuant to this section:

(1) A written request may be made to the public record officer of the public entity involved. The public record officer shall promptly respond to the written request but in no event later than ten business days from receipt of the request. The public record officer shall respond to the request by:

(a) Providing the record in whole or in part to the requestor upon payment of any applicable fees pursuant to §§ 1-27-35 and 1-27-36;

(b) Denying the request for the record; or

(c) Acknowledging that the public record officer has received the request and providing an estimate of the time <u>reasonably</u> required to further respond thereto;

(2) Additional time to respond to the written request under subsection (1)(c) of this section may be based upon the need to clarify the nature and scope of the written request, to locate and assemble the information requested, to notify any third persons or government agencies affected by the written request, or to determine whether any of the information requested is not subject to disclosure and whether a denial should be made as to all or part of the written request;

(3) If a written request is unclear, the public record officer may require the requestor to clarify which records are being sought. If the requestor fails to provide a written response to the public record officer's request for clarification within ten business days, the request shall be deemed withdrawn and no further action by the public records officer is required;

(4) If the public record officer denies a written request in whole or in part, the denial shall be accompanied by a written statement of the reasons for the denial;

(5) If the public record officer fails to respond to a written request within ten business days, or fails to comply with the estimate provided under subsection (1)(3) of this section without provision of a revised estimate, the request shall be deemed denied.

The Department of Social Services' (DSS) is in receipt of your public record requests of August 8, 2021, as previously acknowledged in response letters on August 20 and September 9. DSS can provide the following responses to your requests, in order:

- No granting or denial letter was sent from DSS pursuant to your request for "the legislative grounds for having [you] complete a W-9." DSS did not request the W-9 in the instance you refer to.
- Laura Nord (or Charter), Rogine Page, Mary Rea, Leslie Lowe, Kim Malsam-Rysdon, Shawnie Rechtenbaugh, Jason Ravnsborg, and Richard Baumer do not work for DSS, so DSS has no information to provide for them.

As for Laurie Gill and Nancy Giovanetti, per SDCL 1-27-1.5(7), personnel information, other than salary and directory information, is not a public record open to inspection or copying. Therefore, DSS cannot provide their personnel records. Salary and routine directory information can be found for state employees at https://open.sd.gov/employees.aspx and https://apps.sd.gov/dp51SWPB/DP51InternetSearch.aspx.

- Pursuant to SDCL 1-27-1.5(12) correspondence, memoranda, calendars or logs of appointments, working papers, and records of telephone calls of public officials or employees are not records open to inspection or copying. would require us to create a type of report that does not currently exist, the information you request is not subject to production under the open records laws pursuant to SDCL 1-27-4. In an effort to be of assistance, DSS can provide the following information:

- As of October 11, 2021, there are 9,884 individuals on LTC Medicaid. Of those individuals, 2,759 are in nursing facilities (including hospice and swing beds) and 7,125 are not.
- Since 2017, DSS has completed 3,695 disability determinations. Of those determinations, 2,134 individuals were found disabled, and 1,535 were found not disabled; also, in 26 instances DSS upheld a Social Security Administration determination of no disability.
- Non-emergency medical transportation to covered medical appointments is covered with no cost share for full coverage Medicaid recipients.

In the above-referenced <u>RECORDED conversation</u> on 10/29/21, I clearly conveyed the following FACTS in response to Linda Williams feinting concern for me as a disabled person calling for help by asking "*How are you?*" and "<u>What is it exactly that you want me [and 'us']</u> to advocate for you?"

- 1) "INEED MEDICAID" Because the STATE agents are continually refusing to provided me with needed STATE MEDICAID insurance coverage, I as a "totally and permanently disabled quad-amputee" am left with only two choices regarding the acquisition of needed medical services from the medical community: Either I go into debt slavery and the ruining of my personal and credit reputation by privately contracting with private medical service providers for the 20% costs of prescribed medical treatments, which MEDICARE does not provide for (if provided at all by the national government) WHEN I HAVE NO "INCOME" AND HAVE NO MEANS OF PAYING THESE COSTS prescribed by my doctors, or, settling on the FACT that the doctors and medical service providers offering services to me that I need WILL REFUSE TO PROVIDE THESE NEEDED SERVICES BECAUSE I CANNOT CONTRACT WITH THEM AND THEIR "DEBT COLLECTORS" for debts that I already know that I cannot pay "as a disabled person with no legs and no fingers";
- 2) <u>I was</u> criminally evicted during the middle of the Winter, during national PANDEMIC, and EVICTION MORATORIUM while paying rent and complying in all other aspects with the laws, and the after arriving to the STATE OF SOUTH DAKOTA as a refugee <u>asking for help</u>

on behalf of myself as well as on behalf of the Sovereign People of South Dakota who would now be compelled to be paying for my medical costs for which the Taxpayers of the STATE OF MICHIGAN otherwise shirking responsibility; and that I was denied such help as a reported CRIME VICTIM because the ATTORNEY GENERAL was more preoccupied with his own "defense" to being placed on criminal trial himself for manslaughter.

- 3) <u>I needed further assistance in getting back the SOCIAL SECURITY payments</u> that were illegally taken from me by the U.S. TREASURY and SOCIAL SECURITY ADMINISTRATION for many months after MEDICARE kicked in and the STATE OF MICHIGAN and CENTERS FOR MEDICARE AND MEDICAID used the COVID PANDEMIC as the basis for their dereliction and (criminal) GROSS NEGLIGENCE in refusing my calls in requests for assistance in completing proper application documents to keep this "hardwired" and streamlined process for "deducting MEDICARE PREMIUMS" from depriving me of that money from the time MEDICARE went into effect until Linda Williams could competently assist me in getting "qualified" and keeping the same thing from happening after I arrived to South Dakota.
- 4) <u>I am being denied for MEDICAID based upon "level of need"</u> without anyone defining IN WRITING the procedures or the laws defining how "levels of needs" are determined and the qualifications of those making the determination to DENY me (repeatedly) based upon this criteria WHILE ALSO COMPLETELY DISREGARDING MY MULTIPLE WRITTEN COMPLAINTS and DENYING all of my "Open Records" document requests for this information under the laws of "government transparency" ... all in violation of the "Open Records" laws.
- 5) I am being DENIED transportation services (or being compelled to ask for special treatment and forgiveness for "inability to pay") because I do not have MEDICAID, which otherwise pays the costs for me to get to and from doctors and medical service providers; and I thus need help in getting that rightful access to my community without having to humiliate myself with groveling for rides as otherwise required by both STATE and UNITED STATES laws governing the treatment of disabled people "with dignity".
- 6) Because Linda William's phone call was unplanned (without any courtesy whatsoever to me as a supposedly "fully informed" disabled man in charge of my own daily scheduling and without Linda Williams having first scheduled such an "important" meeting with her "supervisor" and "CORPORATE board" present on the call with me), I needed this conversation to resume at a later time because Linda William's "untimely call" was at that very moment interfering with my need to finish getting dressed and catching a scheduled transportation vehicle to take me to doctor-prescribed physical treatment for myself (to which Linda Williams responded by insisting that she take even more of my time anyway on the phone instead of honoring my kindly stated wishes and expressed needs).

The above "Notices" bring into question two important issues that must be lawfully addressed:

Unfortunately, this is what happens when th pressures build up against disabled people like me who have been placed by the STATE in the position of having to deal with so many business people in not only the medical field, but in the business and government fields as I defend myself against DEBT COLLECTORS, crawl on my belly and grovel for charity assistance from private medical service providers' "managerial office personnel and financial managers" who are demanding "verification" of my "hardship applications" (which I have to complete for EVERY medical service provider that will even consider waiving the 20% that MEDICARE and the DSS/DSS/DOH also REFUSES to pay on on of my medical necessities and services as a recently "totally and permanently disabled quad-amputee" who doesn't even have the freakin' fingers to complete the applications, and doesn't even have the transportation to get to the freakin' Post Office to mail all of this stuff so that people like those MONUMENT HEALTH can then start demanding that I provide copies of my private contracts (being itself over 70 pages) with my apartment landlord, proof of all of my other monthly billing statements, and all of these other tedious tasks that essentially turn me as the "BENEFICIARY" of "government welfare" in the SLAVE of the service provider, of a DEBT SLAVE to the debt collector CORPORATIONS. Last time I checked the THIRTEENTH AMENDMENT to the U.S. CONSTITUTION forbid government and its CORPORATE LICENSEES from subjecting "We, The People" to "involuntary servitude". I think I made myself pretty clear in your office yesterday that all of this runaround that I am getting by your cohorts of the STATE and your STATE LICENSEES as CORPORATE SERVICE PROVIDERS as I am being COERCED into debt slavery or FORCED LABOR as the only other alternative, is "INVOLUNTARY". In any regard, I have included for "Angie" what I had sent last week to "Amber" by attachment, again with my apology for the misunderstanding and misinformation that I espoused in front of her supervising regional manager. It is most conveniently (to me) attached below.

Next, I wish to recap a few things from our hour-long discussion yesterday in your conference room with my transportation driver/friend and Angie;s subordinate also present as added witnesses to this meeting.

As your STATE "right arm" (DSS) was pointing your finger to your STATE "left arm" claiming its out of your hands and while placing the onus of "fault" upon me for "talking to the wrong people" and claiming that you had no clue about who even Jennifer Lewis was - when is YOU that works for the STATE, not me - I did provide Angie Reichert with the completed "Application" for MEDICAID that she sent to me (which had another unfamiliar name at the top not specifically identifying it as MEDICAID as I recall) - but with the date of my "signing (probably under criminal "penalty of perjury" as another threat against my "slavery" status and slap in the face of my "dignity" as a disabled sovereign American) was backdated to correspond to the date I completed my FIRST APPLICATION FOR MEDICAID at the request of Jennifer Lewis who is the cohort of ALL OF YOU at the STATE which NONE of you apparently know about. Again, my signing and dating such a "redundancy" of application to satisfy your STATE efforts to force me to go through yet another of your wasteful "hoops" so you can justify your jobs at taxpayer expense while subjecting me to the assertion of your coercive will" by "color of law, rules and procedures" as a new government slave to YOUR paperwork (similarly to what the CORPORATE "STATE LICENSEES" are doing to me in the private sector) was carried out by me as promised on the phone last week and delivered to you yesterday at the end of our meeting.

Third, with regard to your intent to inform the DHS that they need to waste more time sending Laura Nord / Laura Charter or whoever she wants to call herself now, or her boss Rogine Page to enter my home for another "home visit" at taxpayer expense, I have to say the following in reiteration of yesterday that I will "show them the door" right away if they are not prepared right away to "show me the law" on EVERYTHING they are doing in their decision-making:

1) Laura Nord/Charter and Rogine Page are just two of about 14 people whom I wrote on TWO SEPARATE OCCASIONS IN COMPLAINTS (6/2/21 and 6/19/21) accompanied with OPEN RECORDS REQUESTS that ALL HAVE IGNORED for the last 6 months. NOBODY on that list of individuals will be allowed to even past the threshold of my doorway into my home unless or until they are not only ready to the "show me the law" on the basis off their claim for disqualifying me 8 months ago for MEDICAID based upon my "not meeting the level of need" as a totally and permanently disabled quad-amputee. Further, NOBODY from that list will be allowed to enter my home without providing me with their WRITTEN ANSWERS to BOTH of my COMPLAINT letters given the OPEN RECORDS RESPONSES (attached) showing the STATE "LIARS" refusing to answer any of my

requests" submitted IN GOOD FAITH under the OPENS RECORDS LAWS for answer to my simple DEMAND that you STATE "agents" just "show me the law". What are South Dakota "Taxpayers" paying these idiots a lot of money to do(?), think up new and creative ways to deny even showing laws to a rational disabled person who is looking for some simple answers to vague and deceptively written "DENIAL OF MEDICAID" letters?

The Plaintiff also asserts that DSS hired Jeanie Montgomery (Caucasian) as an ASA

Specialist instead of Irene Red Cloud (Native American). (Doc. 46 at 20.) Rogine Page, the Hiring Supervisor for that position, testified that Montgomery had "a lot of work experience," including prior caseworker experience at a mental health facility. (Page Dep. 140:22-141:6.) Montgomery's Rationale for Appointment stressed Montgomery's experience as a nurse, which Page believed would be helpful for the ASA Specialist Position. (*Id.* at 142:6-10.) Additionally, Page testified that Red Cloud had a "sketchy" job history, because "this job was three months, this job was two months, this job was – oh, that was ten months... That concerns me as a supervisor who has not had any Specialists for a year as to her work history." (Page Dep. 150:7-15.) Additionally, Red Cloud had not been employed since 2003. (Page Dep. 150:18-19.) Perhaps most importantly, Page testified that Red Cloud would not accept any less than \$17.00 per hour, and that she would not have been

able to get that as an ASA Specialist. (Page Dep. 154:3-16.)

So clearly the answer to my question a couple of pages back is that <u>Rogine Page is a "team player"</u> with long history of proven DISCRIMINATION. 
