Dear Esteemed Members of the Congressional “Committee on Oversight and Accountability”
Concerned About the “*Weaponization of the Federal Government*,” and U.S. Attorney General
Merrick Garland,

I have already written to all of you before concerning my own case as a “*totally and permanently disabled quad-amputee*” that was illegally evicted (during a COVID pandemic and EVICTION MORATORIUM) from the STATE OF MICHIGAN (in 2021) with MEDICAID intact when I recovered from my homelessness in the STATE OF SOUTH DAKOTA ... but have ever since then been DENIED “*MEDICAL ASSISTANCE*” (a.k.a. “*MEDICAID*” in South Dakota). However, NONE of you have responded back to me after I showed you how the “*ADMINISTRATIVE ‘DEEP’ STATE*” and the UNIFIED JUDICIAL SYSTEM – both being operated through the STATE BAR [CRIME SYNDICATE] – has “*railroaded*” my case(s) and have added the criminal “*deprivation of rights under color of law*” to the other previous “*denial*” issues. Except for a single courtesy phone call from Congresswoman Harriett Hageman's office staff, Rachael, suggesting I go to my own Congressional leaders in South Dakota (which I already did to no avail) ... I have had no other replies from any of you.

Today, I write to you concerning a completely different SET of cases, which have similar “*style*” of criminal corruption taking place; but much more intensely, placing a man – a whistleblower on STATE and UNITED STATES “*RICO*” enterprising similarly playing out in the STATE OF WISCONSIN (and extending, like my case, to the STATE OF MICHIGAN) showing the “*WEAPONIZATION OF [STATE and] FEDERAL GOVERNMENT*” that has, like with me, caused him such severe injury that he too has for several years been confined to a wheelchair and is teetering between LIFE AND DEATH as a political prisoner being held captive for the past fifteen (15) years of his life for “*whistleblowing*” and presenting evidence about “*dirty*” cops and

prosecutors, and judges altogether operating in sedition and treason in the EASTERN DISTRICT OF WISCONSIN.

Attached is a 135-page expose' showing how that Wisconsin case of Reverend Jason Goodwill shares the same CRIMINAL elements embedded in the U.S. DISTRICT COURT for the EDW, who are all connected to the STILL UNRESOLVED "RICO" and "ANTITRUST" cases surrounding SUPERVALU /IOS / INMAR being involved in the funding of international terrorism over 20 years ago but "*swept under the rug*" by these "*federal*" judges operating in Wisconsin. It is worth pointing out that one of Rev. Jason Goodwill's "*STATE judges*" is also the one and the same as the one mishandling the Steven Avery case, of which the NETFLIX television double-series "*MAKING A MURDERER*" was all about.

PLEASE ACT IMMEDIATELY to review the accompanying 135 pages connecting these Wisconsin and U.S. "*judicial usurpers*" to the cover-up of two very different "RICO" crime sprees. Right now, the very life of CRIME VICTIM and severely DISABLED man, Rev. Jason Goodwill, is hanging between life and death and depending upon YOU to set forth the "*right action*" to first rescue him from DANGER, and then to hold appropriate "*investigative hearings*" about all of these STATE BAR OF WISCONSIN members operating such a racket that involves not just the criminal coverups of Reverend Jason Goodwill's "*whistleblower*" case, but the also the coverup of the highest "*tier*" of the mega-billion dollar (financed by WALL STREET) SUPERVALU/IOS case that was (and still) linked to the funding of international terrorism (and still allowing those "*masterminds*" at the top of that billion-dollar scheme to NEVER be exposed and prosecuted, thanks to those "*dirty*" federal judges in Wisconsin).
